On or about Sunday May 31, 2020 at approximately 02:00am, Officer M. Rodriguez with IMPD was detailed to downtown emergency response group (ERG) riot control. During crowd control at approximately 150 Capitol Ave, Officer Rodriguez standing by the roadway next to a fully marked patrol vehicle with its emergency lights conducting an investigation with other officers was almost struck by a vehicle. A 2009 Ford Crown Vic bearing In God We Trust plate was traveling south bound on Capitol Ave at a high rate of speed. The vehicle began moving recklessly unrough traffic changing multiple lanes and almost striking other vehicles in the roadway. Once approaching where officers were conducting an investigation, the white Ford swerved directly toward where Officer Rodriguez was standing almost striking him. Officer Clayton had to yell at Officer Rodriguez to move from being struck by the vehicle do to Officer Rodriguez back toward the oncoming vehicle. Officer Rodriguez made an evasive maneuver to avoid being struck. Multiple other officers witness the vehicle continued south bound in attempt to avoid police.

Officers conducted a traffic stop on the vehicle at approximately 160 W South St. The driver of the vehicle was later identified as W/F Gillian Huff DOB 08-15-1997. Huff advised she did not see the officer in the roadway. Huff refused to answer any other question. Huff was placed under arrest for criminal recklessness with a vehicle and rioting. Huff was transported to central receiving by Marion County Sheriff Department jail wagon. Huff's vehicle was towed to Auto Return by White Gloves towing.
