Lt William Carter swears (affirms) that:

On February 14, 2022 Cameron Lumpkin-Weremay registered Chosen Protection Solutions, LLC with the Indiana Secretary of State. This security company is operated from Lumpkin-Weremay's home address, 5368 Southeastern Avenue, Indianapolis, IN, 46203.

On April 4, 2022 Mary Hutchinson confirmed there is no security license on file for Chosen Protection Solutions, LLC.

Chosen Protection Solutions, LLC advertises admin@chosenprotectionsolutions.com as their company email, and lists the following employee phone numbers; Cameron Lumpkin (317) 604-6124 Jordan Morris (317) 628-0542 Mathew Winslow (317) 242-8019. This information can all be found on the company Facebook page <https://www.facebook.com/chosenprotectionsolutions> . This page lists Chosen Protection Solutions as "Security Guard Service". On this same Facebook page, employees of this security team can be seen armed with handguns, rifles and wearing ballistic vests. The Facebook page was created on March 18, 2022, the same day the video was posted.

On April 2, 2022 at approximately 2 am Chosen Protection Security employees Brian Redding, Jordan Morris and Ashley Wynn were working security for JD's Pub (6920 Eagle Highlands Way) when a person was shot at the location.

In a recorded statement, taken by Homicide Detective Sayles, at JD's Pub on April 2nd Morris states, "I went to my other security personnel Brian's truck to obtain my rifle, my AR-15."

In a recorded statement, taken by Homicide Detective Wright, at JD's Pub on April 2nd Redding was asked "Who was working security?". Redding replied, "All three of us, Jordan was here too. He just walked by he's the other armed officer that was there the security guard that was there. He's my basically supervisor or manager whatever you would call it."

On February 14, 2022 a no contact order against Jordan Morris was issued. On February 23, 2022 Jordan Morris was served in court, by the bailiff, under cause number 49D33-2202-F6-004106. The no contact order states "The defendant is ordered to have no firearms, deadly weapons, or ammunition in his/her possession."

All the above events did occur in Marion County State of Indiana.

AFFIDAVIT FOR PROBABLE CAUSE

STATE OF INDIANA, COUNTY OF MARION, SS:

Lt William Carter swears (affirms) that:

On February 14, 2022 a no contact order against Jordan Morris was issued. On February 23, 2022 Jordan Morris was served in court, by the bailiff, under cause number 49D33-2202-F6-004106. The no contact order states "The defendant is ordered to have no firearms, deadly weapons, or ammunition in his/her possession."

On April 2, 2022 officers with the Indianapolis Metropolitan Police Department were dispatched to 6920 Eagle Highlands Way (JD's Pub) on a person shot. Jordan Morris was on scene as a contracted employee of the business. Morris works for Chosen Protection Solutions, an armed security company, providing security for JD's Pub.

Body worn camera footage from Sergeant J. Warman ID 30710 shows Morris with a black handgun holstered on his left hip.

Video surveillance, taken by search warrant under cause number 49D25-2204-MC-008794, from JD's Pub the night of the incident shows Morris with a black handgun holstered on his left hip. In the same surveillance video Morris can be seen holding a rifle inside the business.

In a recorded statement, taken by Homicide Detective Sayles, at JD's Pub on April 2nd Morris states "I went to my other security personnel Brian's truck to obtain my rifle, my AR-15."

All the above events did occur in Marion County State of Indiana.
