# You Shall:

- 1. be confined to your home at all times except when you are:
  - a. working at employment approved by the court or traveling to or from approved employment;
  - b. unemployed and seeking employment approved for you by the court;
  - c. undergoing medical, psychiatric, mental health treatment, counseling, or other treatment programs approved for you by the court;
  - d. attending an educational institution or a program approved for you by the court;
  - e. attending a regularly scheduled religious service at a place of worship;
  - f. participating in a community work release or community restitution or service program approved for you by the court; or
  - g. participating in any other activity approved for the offender by the court.
- 2. be subject to prosecution for the crime of escape under IC 35-44-3-5 if you violate the order for home detention.
- 3. abide by a schedule prepared by the probation department, or by a community corrections program ordered to provide supervision of your home detention, specifically setting forth the times when you may be absent from your home and the locations you are allowed to be during the scheduled absences.
- 4. not commit a criminal offense during the period of home detention ordered by the court.
- 5. obtain approval from the probation department or from a community corrections program ordered to provide supervision of your home detention before you change residence or the schedule described in subdivision (3).
- 6. maintain:
  - a. a working telephone, cellular telephone, or other wireless or cellular communications device in your home; and
  - b. if ordered by the court, a monitoring device in your home or on your person, or both.
- pay a home detention fee set by the court in addition to the probation user's fee required under IC 35-38-2-1 or IC 31-40. However, the fee set under this subdivision may not exceed the maximum fee specified by the department of correction under IC 11-12-2-12.
- 8. abide by other conditions of probation set by the court under IC 35-38-2-2.3.
- 9. be required:
  - a. if convicted of an offense described in IC 10-13-6-10;

- b. if you have not previously provided a DNA sample in accordance with IC 10-13-6; and
- c. your sentence does not involve a commitment to the department of correction; provide a DNA sample.

# \* GPS as required by law (I.C. 35-38-2.5) on violent offenders. The Marion County Prosecutor's Office must provide addresses to be protected to Community Corrections at the time of Sentencing.

The defendant is released from custody and is hereby ordered to appear at Community Corrections, 200 E. Washington Suite W-121, by 5:45 p.m. this date or 8:30 a.m. the next business day. Failure to report will result the filing of a Violation with a warrant request.

The defendant is to be held in the Marion County Jail until placement.
